# Call to Order

#### Treasurer's Report

Ed Farley explained structure of the latest financial report. Past payroll expense discrepancy is being cleared; the \$3,500 figure had been double

counted under two categories. Denny suggested adding another line item to note apparent surplus caused by early pledge payments. Sharing the Plate activity is working well to also accrue more funds for UUFEC. Denny said line items may be needed for upkeep, etc. on the property for possible acquisition, as budget projections. Ed said Chair of Finance Comm. would

like another line item for Reserve.

Rod's salary has been "averaged out" to a correct level after a few years' fluctuations. It was noted that RE did very much better than expected thru unexpected successes in fundraising.
