Chris Jordan and I worked with Doak to find a place on the home page for his columns ("Notes from the Journey"). He sent his first column about a week ago. So he is connected directly to Chris and they can work together as needed.

Facilities / Buildings & Grounds Committee; Chair: Fred Boyer; Liaison: Winky Sweet

During past 30 days, much has been accomplished. But, still much to do:

1. Lloyds of London has again agreed to insure our building for only \$2,505.38. Our coverage is for \$535,000 on building and \$65,000 for personal property. There is a \$1000 deductible. We have excluded wind and hail damage. I recommend we establish a hurricane disaster account and fund at roughly \$5,000/ year. We are covered till 7/7/2019.

The board discussed insurance issues and agreed that we have sufficient funds to use in cases of hurricane disaster and not to set up a separate fund. 2. A tree contractor trimmed all overhanging limbs and branches. His fee was \$700.

3. At least two of our members object to orientation of our monolith UUFEC sign. Indeed, while it is quite conspicuous for southbound vehicle traffic, it is not well oriented for traffic headed north. I estimate to move sign perpendicular to street, would cost \$4-6,000. I will ignore this "need" unless The Board decides otherwise. The Board agrees that nothing needs to be done at this time.

4. On 4 July, volunteers harvested \$219 for a military cause (*Presidents Addendum: Healing Paws For Warriors, helping wounded veterans*) with use of our parking lot. Perhaps, our RE program could consider as a future fund-raiser.

At this time, the Board prefers using this money to donate to community causes.

5. Lilly Pads has failed to pick-up/pay for 4 pews they agreed to purchase. Fred will follow-up.

6. A roofing contractor declined (again) to estimate replacement cost for 380 linear ft. of soffit. Fortunately, associated with this concern, is absence of additional rodent intrusions. (possibly, a small application of pesticide in basement has worked?) However, there are two areas of serious damage that can possibly be resolved internally. Need a volunteer or two!

The Board, agreed that many of the soffits show severe damage and that there are trees that need aggressive pruning or possibly removal to prevent further damage to the building. VP Julie will communicate further with Fred.

7. The new minister's office has been roughly configured to his request.

8. On 15 July, a second hour feedback session discussed Russell & Robin Preston's interest in our vacant quarter acre lot 37. Five congregation members, Fred and Gil, looked at the lot, walking the property line and then discussed what to do with the property. All Five of the participating members said not to sell the property and then brainstormed possibilities for the land. The Board would like to investigate the use of solar panels on our building. VP, Julie will contact the Democratic Solar Cooperative, to explore this option. The Board will also attempt to take advantage of the generous offers from this group to volunteer with various projects around the church.
