At our last COM meeting on December 13, 2018, it was decided that Jane Park would succeed Kathy Roniger as chair of the COM, as Kathy has completed her three year term, serving as chair for 2018. It was noted that Blake Farley's name had been suggested as a replacement for Kathy.

We brought Diane Gibson up to date on landscaping plans for the church. In particular, discussion was had about how various trees would be dealt with.

We discussed an email received by Doak from a member involving some lingering concerns about a previous member and action taken by the church a few years ago. It was determined that it was not an issue for the COM to take up again, and that the matter would be handled by Doak.
