CANVASS REPORT TO THE BOARD

The pledge drive is coming along amazingly well, under the circumstances.

As of March 28, 28 of our 67 households have pledged a total of \$73,108.12, 81% of our goal of \$90,000.

Collectively, these 28 households pledged nearly \$5,900 more than last year (about an 8% increase over what these 28 households pledged last year). Of these 28 households: 15 increased their pledge from last year; 9 pledged the same amount; and 4 decreased their pledge.

IF the outstanding 39 households pledge only 60% of what they pledged last year, we will surpass the \$90,000 goal.
