Building and Grounds Committee Report - July 26, 2020

Hello All.

A contract termination letter for custodial services was prepared and signed on July 24, 2020 effectively notifying Mr. Bildan Wilson that due to the COVID19 circumstances the church could no longer keep on custodial services and the services are to be terminated as of July 31, 2020. To my knowledge we paid Mr. Wilson an extra month payment as severance compensation. This move will save the church approximately \$600 a month.

Our landscaping company continues to mow and edge the grounds twice a month (every 2 weeks). The cost of the service is \$125 per mow (\$250 a month). I remain pleased with the quality of the service. In a discussion with John Holt regarding the UUFEC Budget challenges, John suggested the mowing services be reduced to monthly or maybe once every 3 weeks to reduce church expenses. With almost daily summer showers in the Niceville area, the grass tends to grow rapidly; and the twice monthly mow is just keeping our landscape in check and not appearing too ragged and seedy. Also, I am not positive that the landscaping company can work a once-every-3-week mow into their existing schedule. Furthermore, keep in mind that in the fall and winter months we do not require, use, or pay for landscaping services at the church. However, reducing the landscape frequency is a Board decision and I will contact the company with any changes once a determination has been made.

I have decided to hold off on any Cleanup events for the next few weeks due to the extreme heat we have been experiencing recently. The heat index can jump to near 100 degrees by 9 am in the past month and I worry for the well-being of any cleanup volunteers. Possibly we can have an early morning cleanup start time. I am thinking 7am to 10am on a Saturday in the not too distant future. I will perform an informal telephone/text/email survey to see if folks are willing to get up this early on a Saturday.

After a quick walk through of the Building and Grounds last Friday, I did not find any obvious issue with the building or the grounds.

- Prerecorded: Words of Welcome, Chalice lightings, a Time for All Ages, Prayer/Meditation Message from a
  UU Minister, and two musical videos. These additions have increased the length of the services to about 30 40 minutes.
- Contacted 5 UU Ministers of larger UU congregation for permission to stream their virtual sermons on our UU website and Facebook page.
- Coordinated with the Announce team, DRE and RE Committee and Communications Team to produce and publicize the services on the UUFEC media.
- Researched and vetted speakers from other UU congregations for month of August (5 services) as well as the sermon titles.

More volunteers from the Fellowship are needed to train others on computer technology required for a virtual service, assist with recording worship elements, and to assist with researching UU ministers and lay people to speak in October or until the Board can contract with another minister later this year,

I regret having to write this email, but I feel I cannot continue serving as chair of RSC. When I volunteered for the position, I was eager and really didn't realize how much more difficult it would be to stream four/five weekly services every month. I am finding that the hours to perform this task require many more than is reasonable for a volunteer.

Today I emailed Announce the complete schedule of speakers and sermon titles for the month of August. I will also find speakers for September. My resignation will be effective September 30.

I do have a recommendation for the Board to consider. It is that the board hires a temporary. part time Director of Religious Services. That individual would be responsible for the duties of the religious services as well as coordinating the work of the RSC with the Announce team to produce the final services. This position would end when a part time professional ministry is contracted. I might add that I would not apply for the position.

If this is an option the board wishes to explore further, I would be happy to develop a job description that would detail the main duties, skills and experience desired for the job.

I regret that my age and health does not permit me to fulfill this commitment. I am appreciative of those who have lent their support to RSC.

Social Justice Committee

The SJC had two meetings in July: July 10 and 24.

The SJC would like to contribute to local organizations that are serving the needs of the community via education, aiding in paying utilities, housing, rent, and groceries. We have identified Caterpillar 2 Butterfly and Youth Village as the two organizations. In addition, Opportunity Place has reached out to individuals requesting help in providing a dinner to their 22-25 residents, and the SJC is going to participate in this project.

We are adding these two groups because we wanted to support local charities led by people of color. These chosen groups are from initial recommendations and phone calls to the organizations, for "due diligence". These groups align with UU principles..

We are still supporting our other three local partners:

- --Shelter House
- --Niceville Sharing and Caring
- -- Opportunity Place

How will we send funds to these organizations?

The SJC is requesting UUFEC to modify Share the Plate for all the nonprofits we now give the Share the Plate collections to during the pandemic period. By highlighting one charity a month, introducing the congregation to each organization via video on Sunday and on the website, we feel this will make an impact and allow our congregation to participate in charities that speak to them. The congregation would be able to donate through FaceBook, UUFEC website or by mail. There is a platform called Zelle that does not charge a fee and could be used to donate. SunTrust offers this option.
