Review minutes from 12-21-20

TREASURERS REPORT:

Still surprisingly ahead. Income at 97%.

We received a generous bequest from the estate of Daisy Horne. It is restricted and will be placed in the endowment fund.

John is sorting out payment's on UUFEC mortgage. The church refinanced in 2009, but we have been making 2 of the original payment amounts (before refinancing) instead of the one refinanced payment every month.

PPE Loan can include utilities, but the rest of the loan will not be forgiven, as Doak is no longer on staff. We may be able to obtain loan forgiveness, since our other employees are still on payroll and Doak retired (as opposed to quitting or being fired). We are able to pay the PPE loan back now.
