## **OLD BUSINESS**

### 1. COVID UPDATE:

Gil's April COVID report referenced "re-opening guidelines," in Reston, VA, including safe targets" for various covid-related target which continues to highlight as useful guidelines. Here are local measures #s in bold from Okaloosa County (OC) Health Department report for the week for **Sept 12-18, 2021.** 

- Target Daily new Cases: < 1 per 100,000</li>
  - Current OC: 55.4/100,000 daily new cases (weekly total of 388.1/7 days)
- Target Test Positivity: < 3% assuming testing is widely performed</li>
  - Current OC: 16.7%
- o Target ICU beds occupancy by COVID patients: less than 50%.
  - Current OC: 56.5%

Any recommended changes to current building use policy?

The Board agreed keep the current building policy as is and revisit at the October meeting.

## A. Update from the Endowment Committee\*

The committee met on August 25 and passed the following motion:

Moved by Karen Lauer and seconded that a recommendation for disbursement of up to \$80,000 from the Endowment Fund for maintenance, capital improvements, and renovations of the

Fellowship's building and grounds be made to the Board of Trustees for approval. The motion passed.

John Holt offers the following motion for the Board:

I move that a disbursement of up to \$80,000 from the Endowment Fund be made for maintenance, capital improvements, and renovations of the Fellowship's building and grounds and that Board work with the Endowment Committee to develop procedures for monitoring the responsible use of these funds.

John moves the motion. Gil seconds. The motion passed unanimously.
